# Crisis in NHS Worrying

One in 10 nurses are leaving the NHS in England each year, according to official figures, raising fresh concerns about staffing shortages in our hospitals. NHS England published data which showed that just under 33,500 nurses left the service in 2016-17 -3,000 more than joined and 20% higher than the number who quit in 2012-13. The worrying figures come amid an ongoing winter crisis fueled by rising

demand, coupled with staff and bed shortages. The next generations of nurses aren't coming through the system as quickly as we the public would like and so we are seeing the most experienced nurses becoming demoralized and leaving. In Northern Ireland the demand for more nurses has risen dramatically as the shortfall currently stands at 2000 across the region. So we

have to ask ourselves 'Why is this happening? The sub working group have been exploring this during discussion at their meetings and are clear that over the last number of years the gradual erosion by the Health Trusts and Boards of Terms and Conditions of Service together with the lowering of Standards in the service has led to many saying 'Enough is enough and going elsewhere seeking better pay.

## NPC Dignity Code should be part of Care

At the dignity day event run by the NPC branch in Northern Ireland speakers at the event called for the implementation of the dignity code to be part of the care package for the care of our elderly. It came on the back of the Commissioner for Older People's report into Dunmurry Manor in which Eddie Lynch carried out an investigation after receiving complaints from relatives into the degrading care and treatment their loved ones were receiving in the home. The report 'Home Truths' highlighted some of the worst treatment patients received at the hands of their carers. It also highlighted the lack of standards and training that existed in the home. Their was a high turnover of staff since it first opened as staff working in the home did not want to be part of the regime. Speakers included our own Victor Murphy who represented Patricia Mc Keown (Regional Secretary) who could not attend as she was at a meeting in England. While he spoke about the issues happening in our region in regards to the health service he also highlighted the report that

was done by The Intergenerational Committee led by Lord David Willetts 'A New Generational Contract' in which he criticised the committee as been a right wing think tank. He also called for the unions and the public to unite in a campaign to save our NHS from the severe damage that this Tory government has done. He went on to say that it was important to get our government up and running in NI but not at any price. Speakers coming after Victor welcomed his comments and were encouraged by what he said in relation to the Intergenerational Report. Other speakers endorsed the call for the Dignity Code to be implemented into our hospitals and care homes for the elderly. John Martin in his closing speech thanked everyone for coming to the event and said that it was up to all of us to again start writing to our MLA's and the churches who didn't respond in the past. He thanked the Protestant church for their response as they were the only ones who took the time to do so. At that the meeting closed and everyone went home.

# Education System failing our children.

. A primary school principal who spoke out over the education cash crisis back in November 2018 has said that it was "humiliating" to be seen begging for help. Dr Graham Gault wo is the principal of Maghaberry Primary School admitted he was afraid he was damaging his reputation when he addressed the Northern Ireland Affairs Committee on the deepening funding concerns facing

education. "In many respects it was humiliating, crying for help", he said, after revealing how parents have been donating toilet roll, tissues and soap to his cash-strapped school. He went on to say that this was not the position he wanted to find himself in but that the crisis is here no matter where you look. In detailing the pressure his own school is facing, Dr Gault - secretary of the Strategic Principals' Forum, which covers 400 schools and 92,000 pupils - said the one thing giving him the strength to speak out was the level of trust his own school community had in him. The amount of support that Dr Gault has received from both governors and parents has been as he described it

himself very generous and understanding. Normally he described himself as been a quiet man but he felt the need to speak out on this very serious crisis. Dr Gault, a father of two daughters, said he was grateful for the opportunity to address the NI Affairs Committee but said it was a difficult one for him personally. Dr Gault said that he has a moral obligation to give each child what they need and that he will continue to do so as the budget for the school allows. The one thing he did relate to was he can't turn off the heat. The situation is the same now as it was a week ago. While the response from the public there has been no change as far as our politicians are concerned.

#### Public Health News.

The public health agency in their weekly surveillance bulliten indicates that figures show that figures are down since the start of this year on the amount of people getting the flu. However influenza is continuing to circulate in our community and hospital settings across Northern Ireland. Primary Care influenza rates remain below the baseline for Northern Ireland and are below normal seasonal activity. It would appear however that the flu rates have decreased and the number of GP consultations were down on this time last year. Influenza continues to cause quite a bit of havoc when it comes to the workplace environment as workers are not always prepared to take a couple of days off work to make a good recovery. Instead they will come into work when sick and this can be

very concerning when it comes to those group of workers working in our hospitals and care homes. The public need to be made more aware of the seriousness consequences of what the flu can do to you as a person. The virus can bring down a workforce with such speed and haste that the working environment itself can be quite stressful especially when staff shortages develop. So remember to stay at home if you are coming down with the flu or have the full blown symptoms and drink plenty of fluids and keep warm and rested.
