NJC pay award must protect us against cost of living pressures

Throughout this year our membership employed by the EA have kept up significant pressure through industrial action, full strike and action short of strike, in pursuit of pay improvement. The long road to a pay and grading review has reached its destination.

NJC pay 2024: The NJC employers side (England, Wales and NI) put an offer of more than 5.2% to UK trade unions. The UNISON NJC committee consulted members in England and Wales who rejected this offer and have now gone to ballot on industrial action. UNISON members in NI had decided to first secure an NI specific deal on pay and grading. We will await outcome of the England and Wales ballot and developments to follow before we decide what we do next.

Throughout 2024, our bargaining team continued working to protect and secure employment rights and health and safety standards for our members who work as classroom assistants, and in school transport, cleaning, catering, estates and youth services.

Our lay team participates directly in all the EA bargaining directorates - operational services (estates, catering, cleaning, transport); children & young peoples services; education (curriculum and services); finance and HR.



Integrated and Voluntary Grammar Schools

Our key goal is to secure a regional negotiating forum for UNISON members on their pay, terms and conditions. This will require Ministerial support and policy direction from the Department.

We have been successful in including funding for members in these schools so they can receive the benefits of the pay and grading review deal. As they are all individual employers we have launched a strategy to mobilise members in each school to pursue these benefits.

Contentious issues that remain include:

- development of the new EA payroll EA1;
- issues for those on retainer fees during the summer period:
- after school clubs and payment rates;
- the need for a framework recognition agreement with Voluntary Grammar schools and the ever growing integrated sector (all individual employers);
- growing concern around resources for EA youth services;
- implication of the Brazil judgement on the calculation of annual leave for term time workers.
